ARTICLE 1

The San Sebastian International Film Festival seeks to make a positive contribution to the development of the film culture and industry.

ARTICLE 2

The 63^{rd} edition of the San Sebastian International Film Festival will take place in the city of San Sebastian from the 18^{th} to the 26^{th} September 2015. The 14^{th} International Film Students Meeting will take place from the 22^{nd} to the 25^{th} September 2015.

ARTICLE 3

All short films selected to participate in the Meeting will be selected by its Selection Committee composed by Maialen Beloki and Amaia Serrulla from the San Sebastian International Film Festival; Víctor Iriarte, from Tabakalera - International Contemporary Culture Centre and Lorena Montejo, from Donostia/San Sebastián 2016 Foundation.

ARTICLE 4

The Award, sponsored by Orona Fundazioa, to the most cutting-edge short film of the International Film Students Meeting will be endowed with the gross amount of 5.000 euro for the chosen project's director.

ARTICLE 5

The objective of the Orona award is to contribute to the culture's development.

ARTICLE 6

All projects selected for the 14th International Film Students Meeting, whose owners accept the statutes of the prize, will compete for the Orona Award.

ARTICLE 7

The candidature to the Orona award implies:

- The acceptance of this rules and regulations.
- Have completed the online registration form correctly, which can be found in the official website: www.sansebastianfestival.com

ARTICLE 8

The decision of the short film selection will be unquestionable.

The invitation made for each film selected by the San Sebastian International Film Festival will remain strictly confidential between the Festival Management and the directors until such time as the Festival decides to make an official announcement.

ARTICLE 9

The acceptance of the Award does not involve the transfer of the exploitation rights of the awarded work, nor the granting of preemptive rights on works submitted for the contest.

ARTICLE 10

The Orona Award will be determined by a jury constituted for the purpose. The Jury will be comprised of students and chaired by a professor and selected by Orona Fundazioa.

ARTICLE 11

The Orona Award may not be declared void or be attributed to more than one short film.

ARTICLE 12

The Orona Award will be announced on Friday, September 25, 2015, during the closing event of the International Film Students Meeting.

ARTICLE 13

All doubts arising from the interpretation of these rules and regulations will be solved by the San Sebastian Festival Management.

ARTICLE 14

In the event of discrepancy in the interpretation of these rules and regulations, the Spanish version will apply.
